

First Party: The Hashemite University (HU), herein represented by Prof. Dr. Fawwaz M. Al-Abed Al-Haq Al-Zboun, President of the University, or the designee thereof in writing, having its address at Jordan- Zarqa, The Hashemite University, P.O. Box (330127 Zarqa 13133), Tel: +96253903333 Ext 3251, Email: cwsc@hu.edu.jo, hereinafter referred to as "First Party".

Second Party: University of Petra (UOP), herein represented by Prof. Dr. Marwan Al-Muwallid, the President of the University of Petra, or the designee thereof in writing, having its address at: Airport Road, P.O. Box 961343, Tel: +96265715564 Ext: 7302, Nuhak@uop.edu.jo hereinafter referred to as "Second Party".

Whereas The Equality and Sustainability Office at the University of Petra, an Accredited Jordanian Higher Education Institution, (hereinafter referred to as E&S Office) and the Center for Women's Studies in the Community at The Hashemite University, an Accredited Jordanian Higher Education Institution, (hereinafter referred to as CWSC) are linked by common interests; and

Whereas the E&S Office and the CWSC wish to enable cooperation and exchange in all areas of mutual interest; and

Whereas these two institutions wish to expand the basis for friendship and educational exchange between Jordan and;

THE PARTIES, UOP and CWSC HAVE REACHED AN UNDERSTANDING as follows:

ARTICLE I

AREAS OF COOPERATION

The purposes of this MoU include, but are not limited to, the following:

1. The development of student training.
2. The organization of joint academic and scientific activities, such as courses, conferences, seminars, symposia or lectures.
3. The exchange of research and teaching personnel.
4. The exchange of publications and other materials of common interest.

ARTICLE II

LETTER OF AGREEMENTS AND IMPLEMENTATION

In order to carry out and fulfill the aims of this MoU, the two parties will appoint an appropriate person at each of their institutions to coordinate the development and conduct of joint activities. Through these contact persons, either two parties may initiate proposals for activities under this MoU. Specific details of any activity will be set forth in a Letter of Agreement, which, upon signing by appropriate authorities at both institutions and approved pursuant to Article III, will become an integral part of this MoU. **Letters of Agreement** will include such items as:

1. Open the possibility for future cooperation to disseminate knowledge about gender equality, diversity, and equal opportunities
2. Elaboration of the responsibilities of each institution for the agreed-upon activity.
3. Schedules for the specific activities.
4. Any other items necessary for the smooth and efficient conduct of the activity.

The contact persons will additionally be responsible for the evaluation of activities under this MoU according to the practices of their respective institutions. Letters of Agreement will be approved at each institution according to the normal procedures governing the types of activities proposed therein.

ARTICLE III

MOU AS PARENT DOCUMENT FOR PROGRAM AGREEMENTS

This general MEMORANDUM OF UNDERSTANDING shall be identified as the parent document of any program agreement executed between the parties. Further letters of agreement concerning any activity shall provide details concerning the specific commitments made by each party and shall not become effective until they have been reduced to writing and executed by the duly authorized representatives of the parties. The scope of the activities under this MoU shall be determined by the needs of each institution.

ARTICLE IV **ENTRY INTO EFFECT AND DURATION**

Upon approval by each institution, this MoU shall remain in effect for a period of two years unless terminated earlier by either institution. Such termination by one institution shall be effected by giving the other institution at least sixty **days** advance written notice of its intention to terminate. Termination shall be without **penalty**. If this MoU is terminated, neither CWSC nor OUP shall be liable to the other for any monetary or other losses which may result.

ARTICLE V **SETTLEMENT OF DISPUTES**

In case of any dispute or disagreement arising as to the interpretation or execution of any of the terms of this agreement, such a dispute shall be amicably settled; in all cases, the courts of Amman (Palace of Justice) shall have jurisdiction over hearing such dispute.

ARTICLE VI

This MoU is made of six articles, including this article in duplicate; one copy for each party hereto.
